Successful applicants who have a foreign degree have to present their degree certificate with the examinations passed and the scores obtained, translated and authenticated by an Italian consulate, embassy or diplomatic representative in the country of the university that issued the degree together with the respective **declaration of value ("Dichiarazione di valore") not later than the deadline for enrolment for the PhD Research Programme.**
