REQUIREMENTS

Applicants who successfully passed the selection procedure are admitted through the ranking lists.

SELECTION CRITERIA

In order to gain admission to this programme you need one of the following qualifications:

1. a bachelor degree in the Italian degree class L-25 (Agriculture and Forestry) ex D.M. 270/2004 or equivalent qualification gained abroad
2. a bachelor degree in the Italian degree class 20 (Agriculture, Food Industry and Forestry) ex D.M. 509/1999 or equivalent qualification gained abroad
3. a bachelor degree in biology of the partner University Innsbruck
4. another Italian or foreign degree if you certify the following ECTS credit points:
 - 20 credit points in the scientific sectors of the fundamental subjects ("attività di base") of the class L-25 (Agriculture and Forestry), and
 - 30 credit points in the scientific sectors of the typical subjects ("attività caratterizzanti") of the class L-25 (Agriculture and Forestry), related at least to two different subject areas.
 Please note: The correspondence of credit points awarded abroad to scientific-disciplinary sectors will be based on the contents of the exams.

If you have not yet graduated at the time of application:

You can apply if you have acquired at least 150 credit points (ECTS) and fulfil the above requirements. Until your graduation, you will be admitted conditionally. You must have achieved your degree by the enrolment deadline, otherwise you will be excluded.

The official teaching language is English. Therefore, the following language requirements apply, otherwise you will be excluded from the admission procedure:

Entry level (to gain admission)- English: B2

The levels of the Common European Framework of Reference apply.

You will be assessed for admission based on your academic qualifications.

Admission is based on the following criteria:

- full academic background containing list of courses and obtained grades (max. 70 pt)
- final bachelor grade (max. 30 pt)

An additional test/interview is required only in case of parity of score for the last place in the ranking list. The Faculty secretariat informs you in case of an interview.

If you still need to graduate and/or certificate any remaining exams, you are provisionally admitted in the ranking lists.

CONFIRMATION OF STUDY PLACE AND ENROLMENT

Applicants admitted through the ranking list must:

- 1) select the degree course in the application portal and **pay with one of the indicated payment methods to confirm the study place within 18 September 2020, 12 midday.****
The first instalment of tuition fees amounts to 748,50 EUR.
- 2) from 09 September until 16 October 2020, 12 midday, enrol online** in the application portal.

If you do not respect the deadlines, you will automatically lose your place which will be offered to the subsequent applicant in the ranking list.

If by paying the 1st instalment you have confirmed the study place, but you do not enrol, there will be no refund of the tuition fees unless you are a non-EU applicant resident abroad and you do not receive the necessary documents from the Italian authorities in your country.

If you have been admitted to more than one degree, you can only confirm one study place in one of them. With this confirmation you refrain from the admission to the other degree courses and lose the right to move up in the other ranking lists.

If you do not have the required academic qualification, you will be given a conditional offer for a study place and you must submit your qualification upon enrolment. If you achieve your qualification after the enrolment deadline, you cannot enroll and you will lose your place which will be offered to the subsequent applicant in the ranking list. **Advice:** If you achieve your qualification after the enrolment deadline, you should not pay the tuition fees to confirm the study place. You will be able to submit a late enrolment request and, only if there are study places still available, you can enroll by December 18, 2020.

Please note that payment does not allow you to receive student status, which will be acquired upon enrolment.

Applicants with qualifications gained abroad must upload in the application portal:

- the diploma of your qualification: if you are not yet in possession of the diploma, you can upload it upon enrolment at the very latest - until you have not uploaded your diploma, you can only gain conditional admission;
- an official translation of the qualification into Italian (not necessary for qualifications in German or English);
- the Diploma supplement, where it must be indicated: that the student has achieved at least 180 credit points (ECTS) and that the study title gives access to a master programme.

In case of doubt, unibz reserves the right to request further documents (e.g. declaration of equivalent value).

- the declaration of equivalent value of your qualification: if you are not yet in possession of the declaration, you can upload it upon enrolment at the very latest (see next paragraph);
- the valid permit to stay for Italy (only for non-EU citizens legally resident in Italy) - see below chapter "EU-citizens and equivalent" point 2.

The declaration of equivalent value (not necessary for qualifications gained in Austria or Germany, but unibz reserves the right to request it in case of doubt)

If you have a foreign qualification, you must certify that your qualification would grant you admission to a similar study programme in the country where you gained this qualification. For this reason, you must:

- apply for the "dichiarazione di valore" (declaration of equivalent value) at an Italian consulate or embassy abroad (please apply for the declaration as soon as possible since processing times might be long);
- upload the declaration upon enrolment at the very latest, together with the other relevant documents.

Attention: If you have gained your qualification abroad and have not uploaded your diploma, you are provisionally admitted until your study title can be verified.

At the beginning of the academic year you have to submit the originals of the above mentioned documents to the Student Secretariat.

If you have been admitted in the ranking list, but you do not possess a valid entrance qualification, you can be excluded with Rector's decree even after enrolment.
