REQUIREMENTS

Applicants who successfully passed the selection procedure are admitted through the ranking lists.

SELECTION CRITERIA

In order to gain admission to this programme, you need one of the following qualifications:

- Italian bachelor degree old or new system
- University diploma
- Foreign qualification obtained abroad and recognized as suitable

Curricular requirements:

1. You meet the necessary curricular requirements to be admitted to the master if you hold one of the following degrees:
 - a. an Italian bachelor degree in the degree class L-9 (Industrial Engineering) ex D.M. 270/2004
 - b. an Italian bachelor degree in the degree class 10 (Industrial Engineering) ex D.M. 509/1999
 - c. other Italian degree in other degree class old or new system, university diploma or other foreign qualification gained abroad and recognized as suitable
2. In the first two cases mentioned above, candidates must have acquired the following credit points (ECTS) in their previous study career, reported as essential in the list of educational activities of the Italian degree "Laurea in Ingegneria Industriale" (class L-9, DM n. 2359, 16 March 2007):
 - a. Min. 36 credit points (ECTS) in the scientific-disciplinary areas of basic subjects.
 - b. Min. 45 credit points (ECTS) in the scientific-disciplinary areas of the characterizing subjects of industrial mechanical engineering
3. In the third case, mentioned above (1c), the Admissions Committee will check the requirements to determine whether the contents and courses attended in your previous career are equivalent to the disciplinary fields at point (2). If you have gained a foreign qualification, the correspondence of credit points awarded to scientific disciplinary sectors will be based on the contents of the exams passed in your previous study career.
4. Average grade in the bachelor (not including the final exam) of 22/30 (Italian system) or 3,0 (German system).

If you have not yet graduated at the time of application: you can apply if you have acquired at least 150 credit points (ECTS). Until your graduation, you will be admitted conditionally. You must have achieved your degree by the enrolment deadline, otherwise you will be excluded.

In order to be admitted to the programme, you must possess proven language skills at the B2 level (Common European Framework of Reference) of the English language
 If you are not able to certify the above indicated entry level, you cannot be admitted.

Requirements for the Double Degree Programme

In order to gain access to the Double Degree Programme, you need to certify also:

1. 25 credit points in Science and Computer Science (including at least 15 credit points in Mathematics / Statistics and 5 credit points in Computer science)
2. at least 20 credit points in Engineering (at least 10 credit points in Mechanics and 5 in Construction)
3. at least 10 credit points in Economics
4. at least 25 credit points in Logistics

At the end of the 3rd semester you must have passed the exams of the 1st semester and document at least 10 weeks of internship in the industrial sector.

If you do not fulfil the requirements in time, you will not be able to graduate with the Double Degree.

CONFIRMATION OF STUDY PLACE AND ENROLMENT

If you have been admitted through the ranking you must:

- 1) select the degree course in the application portal and **pay with one of the indicated payment methods to confirm the study place within 28 May 2020, 12 midday.****

The first instalment of tuition fees amounts to 748,50 EUR.

- 2) from 15 July until 16 October 2020, 12 midday, enrol online** in the application portal.

If you do not respect the deadlines, you will automatically lose your place which will be offered to the subsequent applicant in the ranking list.

If by paying the 1st instalment you have confirmed the study place, but you do not enrol, there will be no refund of the tuition fees unless you are a non-EU applicant resident abroad and you do not receive the necessary documents from the Italian authorities in your country.

If you have been admitted to more than one study programme, you can only secure your admission in one of them. Doing so you refrain from the admission to other programmes and lose the right to move up in the other ranking lists.

If you do not have the required academic qualification, you will be given a conditional offer for a study place and you must submit your qualification upon enrolment. If you achieve your qualification after the enrolment deadline, you cannot enrol, and you will lose your place which will be offered to the subsequent applicant in the ranking list. **Advise:** If you achieve your qualification after the enrolment deadline, you should not pay the tuition fees to confirm the study place. You will be able to submit a late enrolment request and, only if there are study places still available, you can enrol by December 18, 2020.

Please note that payment does not allow you to receive student status, which will be acquired upon enrolment.

If you have gained your qualification abroad, you must upload in the application portal (if not uploaded upon application):

- diploma of your qualification;
- official translation of your diploma into Italian (translation is not necessary if the certificates have been issued in German or English);

- the Diploma supplement, where it must be indicated:
 - that you have achieved at least 180 credit points (ECTS) and
 - that the study title gives access to a Master course.In case of doubt, unibz reserves the right to request further documents (e.g. declaration of equivalent value).
- the declaration of equivalent value of your qualification, in the case the Diploma supplement is missing;

Attention: If you have gained your qualification abroad and have not uploaded your diploma, you are provisionally admitted until your study title can be verified.

At the beginning of the academic year you must submit the originals of the above mentioned documents to the Student Secretariat.

If you have been admitted in the ranking list, but you do not possess a valid admission qualification, you can be excluded with Rector's decree even after enrolment.

Further information for non-EU applicants resident abroad:

As a non-EU citizen living abroad, you will also have to **apply at the Italian authorities** (consulate or embassy) in your country. The deadlines set by the Italian Ministry of Education, Universities and Research (<http://www.studiare-in-italia.it/studentistranieri/>) must be met. At the Italian authorities, you can apply for one study programme only. Should you not follow this procedure with the local Italian authorities, your direct online application to unibz will be declared null and void.

According to Italian law, within 8 working days of your arrival in Italy, you must have applied for the **residence permit**: as soon as you arrive, get in touch with the Advisory Service and you will be given the necessary information for starting the procedure.

Once you will obtain your residence permit (permesso di soggiorno), you have to hand it in at the Student Secretariat personally or via e-mail.

Please note: Non-EU applicants who declared their residence in Italy, but have not attached to their application a copy of their **valid residence permit** for Italy (see article 39, paragraph 5 of decree no. 286 of 25.07.1998) are ranked together with the non-EU citizen resident abroad.
