ADMISSION CRITERIA

In order to gain admission to this programme you need one of the following qualifications:

- Italian bachelor's degree (old or new system)
- University diploma
- Foreign qualification obtained abroad and recognized as suitable.

Curricular requirements:

The curricular admission requirements are:

1. an Italian bachelor's degree in the degree class L-9 (Industrial Engineering) ex D.M. 270/2004
2. an Italian bachelor's degree in the degree class 10 (Industrial Engineering) ex D.M. 509/1999
3. an Italian degree in another degree class (old or new system), university diploma or other foreign qualification gained abroad and recognized as suitable.

In the first two cases (1, 2), you must have acquired in your personal study curriculum ECTS for teaching activities listed as indispensable in the table relating to the Industrial Engineering degree class (Class L-9, Ministerial Decree no. 1648 of 19 December 2023), namely at least 36 ECTS in the disciplinary areas envisaged among the basic teaching activities and at least 45 ECTS in the disciplinary areas envisaged among the characterizing teaching activities in the Mechanical Engineering field.

In the third case (3), verification of the curricular requirements is carried out by the Admission Committee by considering appropriate equivalences between the contents and teaching activities attended in the previous career and those corresponding to the Mechanical Engineering disciplinary fields.

A further eligibility criterion is sufficient knowledge of and proficiency in further engineering subjects.

If you have an average grade in the bachelor (not including the final exam) of 24/30 or above, you are automatically considered eligible.

Otherwise, you will be invited to an interview to check your suitability for the Master program.

The oral interview to test your preparation will last between 15 and 30 minutes and will be conducted in English in online mode.

Possible topics that will be assessed include:

- Fundamentals of mathematics, physics, chemistry
- basic rules of technical drawing
- design and dimensioning of machines
- notions relating to mechanics applied to machines
- thermodynamic principles, fluid-dynamic systems and thermal machines
- traditional processing technologies and systems
- criteria for the design of industrial plants

If you have not yet graduated at the time of application: You can apply if you have acquired at least 135 ECTS credit points. Until your graduation, you will be admitted conditionally. You must have achieved your degree by the enrolment deadline, otherwise you will be excluded.

Requirements for the Double Degree Programme

In order to gain access to the Double Degree Programme, you need to certify also:

1. Double-Degree “Logistics and Production” with OvGU Magdeburg (Germany)

Applicants to the programme must meet the following requirements:

- 25 credit points within the competence of science and computer science (including at least 15 credits in Mathematics / statistics and 5 credits in Computer Science)
- at least 20 credit points in engineering competence (at least 10 credits in Mechanics and 5 in Construction)
- at least 10 credit points in Economics
- at least 15 credit points in logistics and production management (logistics, traffic engineering, production planning and control)

2. Double-Degree “Smart and Sustainable Production” with TUGraz (Austria)

Applicants to the programme must meet the following requirements:

- documented completion of a 180 ECTS BSc degree programme in Engineering,

To apply for the Double Degree programme, applicants must fulfil the general admission requirements and certify also:

- At least 17 ECTS in the disciplinary areas of mathematics
- At least 19 ECTS in the disciplinary areas of engineering mechanics
- At least 21 ECTS in the disciplinary areas of engineering design
- At least 22 ECTS in the disciplinary areas of theory of machines
- At least 9 ECTS credits from economics.

Ranking lists

The Admission Committee will only evaluate the documents uploaded in the portal by the application deadline.

The general ranking list includes all students who submitted the application for the master.

The second ranking list includes only the students who express their interest in attending the Double Degree Program with Otto von Guericke University Magdeburg (OVGU) or the Double Degree Programm with TU Graz through the application portal.

According to national regulations, simultaneous enrolment in a maximum of 2 programmes is possible (however, the two programmes must not belong to the same class, e.g., LM-33/LM-33 and must differ for at least 2/3 of the course contents).

CONFIRMATION OF STUDY PLACE AND ENROLMENT

If you have been admitted through the ranking list, you must:

- 1) select the degree course in the Application portal and pay with one of the indicated payment methods to confirm the study place within 12 September 2025, 12 (midday). The first instalment of tuition fees amounts to € 600.00.
- 2) until 14 October 2025, 12 (midday), enrol online in the Application portal.

If you do not respect the deadlines, you will automatically lose your place which will be offered to the subsequent applicant in the ranking list.

If by paying the 1st instalment you have confirmed the study place, there will be no refund of the tuition fees.

According to national regulations, simultaneous enrolment in a maximum of 2 programmes is possible (however, the two programmes must not belong to the same class, e.g., LM-18/LM-18 and must differ for at least 2/3 of the course activities).

If you have been admitted to more than one study programme, you can confirm your place for a maximum of 2 programmes by paying the designated fee twice.

If you do not have the required academic qualification, you will be given a conditional offer for a study place, and you must submit your qualification upon enrolment. If you achieve your qualification after the enrolment deadline, you cannot enrol, and you will lose your place which will be offered to the subsequent applicant in the ranking list.

Advice: If you achieve your qualification after the enrolment deadline, you should not pay the tuition fees to confirm the study place. You will be able to submit a late enrolment request and, only if there are study places still available, you can enrol by 12 December 2025.

If you have been admitted in the ranking list, but you do not possess a valid admission qualification, you can be excluded with Rector's decree even after enrolment.

Please note that you do not gain full student status by only paying the tuition fees. This status will only be acquired upon enrolment.

ENROLMENT WITH QUALIFICATIONS GAINED ABROAD

If you have gained your qualification abroad, at enrolment you must upload in the Application portal (if not uploaded upon application):

- the degree diploma of your Bachelor;
- the official translation of your degree into Italian (translation is not necessary if the documents have been issued in German or English);
- the Diploma supplement, where it must be indicated:
 - that you have achieved at least 180 credit points (ECTS) and
 - that the qualification gives access to a Master programme.

If you have gained your qualification abroad in an EU country or in Switzerland, Norway, Iceland, or Liechtenstein, at enrolment you must also upload:

- the Statement of Correspondence of your Bachelor degree, to be downloaded from the ARDI - Automatic Recognition Database – Italy.

If you have gained your qualification abroad in a non-EU country that is signatory to the Lisbon Convention, at enrolment you must also upload:

- the Statement of Correspondence of your Bachelor degree, to be downloaded from the ARDI - Automatic Recognition Database – Italy
- the Statement of Verification of your Bachelor degree, issued by the Italian Information Centre on Academic Mobility and Equivalence (CIMEA).

If you have gained your qualification abroad in a non-EU country that is not signatory to the Lisbon Convention, at enrolment you must also upload:

- the Statement of Comparability of your Bachelor degree, issued by the Italian Information Centre on Academic Mobility and Equivalence (CIMEA)
- the Statement of Verification of your Bachelor degree, issued by the Italian Information Centre on Academic Mobility and Equivalence (CIMEA).

Your admission will be under reservation until the above-mentioned documents are uploaded.

During enrolment, unibz verifies your foreign qualification and may request additional documents if necessary.

If the access title is deemed eligible, the reservation will be lifted. Otherwise, enrolment will not be possible and you will be excluded.

Please note: If you have declared to be resident in Italy but have not attached to your application a copy of your valid residence permit for Italy (see article 39, paragraph 5 of decree no. 286 of 25.07.1998) you will be excluded from the ranking list.
