

The new EU Digital Services Act marks a significant shift in the digital space regulation, establishing – among many other innovations – the liability of major digital platforms in countering the spread of illegal online content uploaded by users.

However, the notion of “illegal content” is defined imprecisely in the Regulation, which simply refers to EU law and to the various Member States legislations.

The vagueness and potential breadth of harmful phenomena affecting individuals in the digital space raise significant interpretative issues in identifying users’ criminally relevant conduct and in outlining the related platforms’ obligations.

While framing some theoretical and regulatory foundations of ISPs’ liability, freedom of expression and EU criminal law, the Symposium aims to clarify – in a comparative perspective – such boundaries of illegality concerning certain categories of online content among the different legal systems within the EU.

The meeting grounds on a research project funded by Alphabet/Google, entitled “Leveling the field. Clarifying the notion of illegal content under the EU’s Digital Services Act”, currently underway at the Free University of Bozen-Bolzano and the University of Bologna.
